During the September 30, 2006 quarter, Registrant will reflect net income of approximately \$760,000 for the three months ended September 30, 2006 compared to a net loss of \$2.6 million for the same period last year. As a result of the discontinuance of Registrant's mortgage operations, Registrant's total expenses during the quarter ended September 30, 2006 have decreased to \$140,000 the from \$4.2 million for the same time period last year. Registrant's only material income during the September 30, 2006 quarter was a \$620,000 gain from the settlement of a debt and \$270,000 in proceeds from a new oil and gas lease.
