(1) Award of restricted stock under the Valero Energy Corporation Non-Employee Director Restricted Stock Plan. The shares of restricted stock will vest annually in equal one-third increments beginning on the date of Valero's annual meeting of stockholders in 2007.

On December 15, 2005, Valero's common stock split 2-for-1, resulting in a 2-for-1 increase in the reported shares beneficially owned by the reporting person. The 5,538 amount does not include 42,058 indirectly owned shares, of which 30,000 shares are held in the name of the reporting person's spouse, and 12,058 shares are held by a corporation owned by the reporting person.
