Absolute Fund is a feeder fund that invests its assets in Concentrated Fund. Glenhill Overseas is the investment manager of Overseas Partners. Overseas Partners is an offshore feeder fund which invests its assets in Overseas Master. Overseas GP is the general partner of Overseas Master. Glenhill Capital, Concentrated Fund and Overseas Master are all private investment vehicles formed for the purpose of investing and trading in a wide variety of securities and financial instruments.
