(1) Derek J Ferber, as an affiliate of FJ Capital Management LLC ("FJCM"), may be deemed to beneficially own the shares of the Centrue Financial Corporation's (the "Company's") common stock held by FJCM, as investment manager for Financial Opportunity Fund LLC which holds shares of 125,000 of the Company and Bridge Equities III, LLC which holds 511,911 shares of the Company. The Reporting Person disclaims beneficial ownership of the shares of the Company's common stock held by FJCM.
