(LS), respectively. 1,970,052 shares of Common Stock are owned by SSFQP and 654,045 shares of Common Stock are owned by LS. The interest of Marxe and Greenhouse in the shares of Common Stock owned by SSFQP and LS is limited to the extent of his pecuniary interest.
