### Item 1.01. Entry into a Material Definitive Agreement

On December 29, 2006, InfoSonics Corporation (the Company) entered into a Distribution Agreement (the Agreement) with Samsung Electronics Argentina S.A. (SEASA) effective January 1, 2007 that allows the Company to distribute Samsung wireless telecommunications devices and related accessories to carriers, retailers and agents in Argentina, Uruguay and Paraguay. The Agreement has an expiration date of December 31, 2007. The Agreement replaces a previous agreement which expired December 31, 2006.
