OTHER EVENTS

On November 10, 2011, the Company announced that its Board of Directors declared a special cash dividend of \$2.00 per share (or approximately \$22 million in the aggregate) payable to holders of record of the Company's common stock as of the close of business on December 12, 2011. The payment date for the special dividend will be January 3, 2012.

To ensure that the Company's option holders are not adversely affected by the special dividend, the Company will adjust all outstanding stock options to maintain the intrinsic value of the option holders' outstanding options.
