Email to utility and HEI employees

In the weeks and months to come, we know you'll continue to have questions about NextEra Energy's future plans. We'll be providing regular updates to the Q&A posted on our intranet. And we also encourage you to attend one of the upcoming town hall meetings to ask questions and share your thoughts.

In the meantime, here are a couple of things to note about communications during the months ahead:

**Public company = Public information**

Some of you have asked why we couldn't inform all employees about the announcement well ahead of time. Because HEI stock is publicly traded, under Securities Exchange Commission rules, the announcement is considered significant information for investors or potential investors. So it can't be shared with a big group (such as our 2800 employees) without also widely publicizing the information externally.

Also, for this reason, many of our employee communications must also be filed with the SEC to ensure the same information is available to the public. This is why you see the legal language that appears at the end of this email on a lot of our employee communications about the transaction.

**Ongoing media coverage**

The potential merger with NextEra Energy is clearly major news—not only for us, but also for our community. So we can expect that the news media will continue to look for new storylines hypothesizing about what may happen in the future. Regardless of media stories, you should know this: NextEra Energy will take the time to get to know our organization, our workforce and our business needs in making future decisions. And until the transaction is completed, we continue to operate as separate and independent companies.
