The securities to be registered hereby are depositary shares (the Depositary Shares), each representing a 1/1,000th interest in a share of 5.75% Series A Cumulative Redeemable Perpetual Preferred Stock, par value \$0.001 per share (the Series A Preferred Stock), of Duke Energy Corporation, a Delaware corporation (the Company).
