- (1) The shares are held by the Patrick and Emily Lo Revocable Trust dated 4-7-99.
  - (2) The shares are held by the education trusts of Mr. Lo's children. Mr. Lo is a co-trustee of each such trust.
  - (3) The exercise and sale reported in this Form 4 were effected pursuant to a Rule 10b5-1 trading plan adopted by the reporting person on November 2, 2015.  
  
The price reported in Column 4 of Table 1 represents the weighted average sale price of the shares sold.
