(1) On February 20, 2013 the Issuer granted the Reporting Person a restricted stock award of 6,806 restricted shares of First Midwest Bancorp, Inc. common stock under the Amended and Restated First Midwest Bancorp, Inc. Omnibus Stock and Incentive Plan which were scheduled to vest in two equal annual installments on the second and third anniversary of the date of grant. On February 20, 2015, 3,403 shares of the originally granted restricted stock award vested, of which 1,139 shares were withheld in order to satisfy the Reporting Person's tax withholding obligations.

(2) On February 22, 2012 the Issuer granted the Reporting Person a restricted stock award of 9,763 restricted shares of First Midwest Bancorp, Inc. common stock under the Amended and Restated First Midwest Bancorp, Inc. Omnibus Stock and Incentive Plan which were scheduled to vest in two equal annual installments on the second and third anniversary of the date of grant. On February 22, 2015, the remaining 4,881 shares of the originally granted restricted stock award vested, of which 1,548 shares were withheld in order to satisfy the Reporting Person's tax withholding obligations.
