- On July 10, 2014 (the "Grant Date"), Mr. Dale was granted 23,809 Restricted Stock Units ("RSUs") representing rights to receive shares of SLM Corporation (the "Company") common stock in the future. Pursuant to the terms of the grant, shares will vest, and will be converted into shares of common stock, in one-third increments on the first, second and third anniversary of the Grant Date. On July 10, 2015, 7,936 shares of such RSUs vested and were issued to Mr. Dale, of which 2,695 shares were withheld by the Company to satisfy Mr. Dale's tax withholding obligations.
