(1) Following the transactions reported on this Form 4, Ms. Taylor continues to hold 60,901 shares directly and 1,719 shares indirectly in a 401(k) account. Ms. Taylor also holds an additional 119,123 vested stock options, 38,449 unvested stock options, and 18,296 target performance shares (the exact number awarded being dependent on achievement of performance goals).

(2) Amount reported has been adjusted to include 107 shares of Issuer common stock acquired by the reporting person under The Prudential Employee Savings Plan between December 31, 2015 and June 30, 2016 based on a plan statement dated June 30, 2016. The acquisition of such shares was exempt from Section 16 pursuant to Rules 16b-3(c) and 16a-3(f)(1)(i)(B).

(3) The options vest in three equal annual installments beginning on February 9, 2011.

(4) The options vest in three equal annual installments beginning on February 14, 2013.
