 - (e) As previously reported in a Form 8-K dated April 2, 2015, the Compensation Committee and Board of Directors of Pier 1 Imports, Inc. (the "Company") approved the fiscal year 2016 long-term restricted stock incentive awards. Each of the Company's named executive officers, other than its President and Chief Executive Officer, received approximately 40% of their fiscal year 2016 long-term equity incentive award on April 10, 2015. These awards vest approximately one-third per year on the anniversary date of the grant, subject to employment on the date of vesting and other terms of the award agreement. Alexander W. Smith, the Company's President and Chief Executive Officer, received long-term equity incentive awards pursuant to his employment agreement as previously reported in a Form 8-K dated March 1, 2015.
