- (3) The NQO became exercisable in full on July 29, 2011, but was subject to earlier vesting in equal one-third parts if the price of a share of Hexcel common stock reached \$15.75, \$21.00 and \$26.25 over consecutive thirty-day trading periods. The option vested as to one-third of the underlying shares in 2005 as Hexcel stock closed at \$15.75 or higher for thirty consecutive days, and vested as to an additional third of the underlying shares in 2006 as Hexcel stock closed at \$21.00 or higher for thirty consecutive days.
