Restricted Shares are subject to the terms and conditions of the MF Global Holdings Ltd. Amended and Restated 2007 Long Term Incentive Plan, as amended, and vest in equal installments on the last day of each fiscal quarter (1) of service following the date of grant, with vesting subject to continued service during each fiscal quarter. Of the 52,385 shares of common stock beneficially owned by the reporting person, 13,850 are Restricted Shares, which vest in four equal installments on the last day of each of the four fiscal quarters of service following their grant date, with vesting subject to continued service during each fiscal quarter.
