(1) Grant of stock under the Issuer's 2011 Equity Incentive Plan in connection with the Reporting Person's services as director.

(2) The aggregate dollar value of the annual equity award to each director in 2014-15 shall be \$250,000, with one quarter of that amount in stock, or \$62,500, to be granted on the first day of each quarter based on the closing price of the Issuer's common stock on the last day of the immediately preceding quarter. The closing price of the Issuer's common stock on the last day of the immediately preceding quarter, September 30, 2014, was \$42.30. Thus, the grant this quarter for services as a director is for 1,478 shares of the Issuer's common stock.

(3) Represents the closing price of Issuer's common stock on October 1, 2014.

(4) All shares are held by Cooperman Revocable Trust.

(5) 5,000 options are vested; the remaining 10,000 options will vest in 5,000 options increments on each of March 11, 2015, and March 11, 2016.
