DEREGISTRATION OF SECURITIES

We originally registered 4,552,446 shares (the "Registered Shares") of our common stock for resale by certain selling shareholders pursuant to a registration statement on Form S-1, as amended (the "Registration Statement") (File No. 333-149173), which was declared effective by the Securities and Exchange Commission on June 26, 2008. The Registered Shares consisted of:

- 1,800,000 shares of our common stock issued on December 21, 2007 pursuant to a private placement (the "December 2007 Private Placement");
- 1,800,000 shares of our common stock issuable upon the exercise of 1,800,000 common stock purchase warrants issued pursuant to the December 2007 Private Placement, and an aggregate of 202,446 shares of our common stock issuable upon exercise of 202,446 common stock purchase warrants issued as liquidated damages warrants under the registration rights agreement relating to the December 2007 Private Placement; and
- 750,000 shares of our common stock issuable upon the exercise of 750,000 common stock purchase warrants issued pursuant to a private placement on May 11, 2006.

Pursuant to Section 10(a)(3) of the Securities Act of 1933, as amended, the selling shareholders named in the Registration Statement may no longer rely on the Prospectus contained in the Registration Statement to resell their shares because the audited financial statements are not sufficiently recent. As such, in accordance with an undertaking by the Company in the Registration Statement to remove from registration, by means of a post-effective amendment, any securities that remain unsold at the termination of the offering, the Company hereby removes from registration the securities of the Company that are registered, but unsold, under the Registration Statement.
