Item 3.02 Unregistered Sales of Equity Securities

On May 1, 2015, May 4, 2015, and May 5, 2015, the Registrant accepted three conversion notices from KBM Worldwide, Inc. ("KBM ") to partially satisfy a \$98,500 Convertible Promissory Note Agreement ("the KBM Note") dated August 6, 2014 with KBM. An aggregate of 10,011,110 shares were subsequently issued to satisfy \$4,505 of the outstanding principal in accordance with the terms of the KBM Note. As of the date of this report the remaining amount currently outstanding on the KBM Note is \$81,530.

On May 1, 2015, and May 6, 2015, the Registrant accepted two conversion notices from LG Capital Funding LLC ("LG") to partially satisfy a \$33,000 Promissory Note ("the LG Note #2") dated February 3, 2014, with LG. An aggregate of 4,994,834 shares were subsequently issued to satisfy \$2,273 of the outstanding principal and interest in accordance with the terms of the LG Note #2. As of the date of this report the remaining amount currently outstanding on the LG Note #2, including accrued interest, is now \$28,075.

On May 1, 2015, the Registrant accepted a conversion notice from Typenex Co-Investment, LLC ("Typenex") to partially satisfy a \$280,000 Convertible Promissory Note Agreement ("the Typenex Note") dated October 1, 2013 with Typenex. 5,075,000 shares were subsequently issued to satisfy \$2,309 of the outstanding principal and interest in accordance with the terms of the Typenex Note. As of the date of this report the remaining amount currently outstanding on the Typenex Note, including accrued interest and other fees, is now \$87,210.

On May 6, 2015, the Registrant accepted a conversion notice from Tangiers Investors LP, ("Tangiers") to partially satisfy a \$750,000 Convertible Promissory Note Agreement ("the Note") dated October 2, 2012 with Tangiers. 8,650,000 shares were issued to satisfy \$3,633 of the outstanding principal and interest in accordance with the terms of the Note, as amended on December 5, 2014. As of the date of this report the remaining amount currently outstanding on the Note, including accrued interest, is now \$445,514.

On May 7, 2015, the Registrant accepted a conversion notice from JSJ Investments Inc. ("JSJ ") to partially satisfy a \$250,000 Convertible Promissory Note Agreement ("the JSJ Note") dated July 14, 2014 with JSJ. 6,824,016 shares were issued to satisfy \$2,507 of the outstanding principal in accordance with the terms of the JSJ Note. As of the date of this report the remaining amount currently outstanding on the JSJ Note, including accrued interest, is \$96,273.
