<b>Proposals</b>	<ol style="list-style-type: none"><li>1. Elect six directors to serve for a term of one year until the 2015 Annual Meeting of Stockholders;</li><li>2. Approve, on an advisory basis, compensation of our named executive officers;</li><li>3. Approve the amendment and restatement of the Company's certificate of incorporation, as amended, to increase the maximum number of authorized shares of the Company's capital stock, all classes, from 145,000,000 shares, consisting of (i) 135,000,000 shares of common stock, \$0.01 par value per share ( Common Stock ), and (ii) 10,000,000 shares of preferred stock, \$0.01 par value per share ( Preferred Stock ), to 165,000,000 shares, consisting of (x) 155,000,000 shares of Common Stock, and (y) 10,000,000 shares of Preferred Stock;</li><li>4. Approve the Immunomedics, Inc. 2014 Long-Term Incentive Plan;</li><li>5. Ratify the selection by the Audit Committee of our Board of Directors of KPMG LLP as our independent registered public accounting firm for the fiscal year ending June 30, 2015; and</li><li>6. Consider any other business as may properly come before the Annual Meeting or any postponement or adjournment of the meeting.</li></ol>
