(NYSE: MDT) (the Company) confirms that, at the close of business on 10 December, 2014, its issued share capital is comprised of 984,912,950 shares of common stock having a par value of \$0.10 each (the Common Stock). The Company also confirms that, at the close of business on 10 December, 2014, there were 9,620,960 restricted stock shares and units with respect to the Common Stock, and 29,747,594 options to purchase Common Stock which are currently outstanding.
