Item 1.01 Entry into a Material Definitive Agreement.

On December 29, 2015, Hortonworks, Inc. (the Company) entered into the Amendment #3 to the Commercial Agreement (the Amendment), which further amends that certain Commercial Agreement (the Agreement) dated June 21, 2011 by and between the Company and Yahoo! Inc. The Amendment modified the existing Agreement so that the current term of the Agreement expires on December 30, 2018. Thereafter, the Agreement shall be automatically extended for twelve-month periods unless a party provides written notice of non-renewal at least 60 days prior to the end of the then-current renewal term.
