Novo Nordisk A/S □ Share repurchase programme

On 28 April 2011 Novo Nordisk initiated a share repurchase programme in accordance with the provisions of the European Commission's regulation no 2273/2003 of 22 December 2003, also referred to as the Safe Harbour rules.

Under the programme Novo Nordisk will repurchase B shares for an amount up to DKK 2.0 billion in the period from 28 April 2011 to 2 August 2011.

Since the announcement as of 6 June 2011, the following transactions have been made under the programme:

With the transactions stated above, Novo Nordisk owns a total of 11,691,314 treasury shares, corresponding to 2.0% of the share capital. The total amount of shares in the company is 580,000,000 including treasury shares.

Novo Nordisk expects to repurchase B shares worth DKK 10.0 billion during 2011. As of 10 June 2011, Novo Nordisk has repurchased a total of 4,518,838 B shares equal to a transaction value of DKK 2,943,465,762.
