- Under the terms of the Key Employees' Deferred Compensation Program (the "Program"), the Reporting Person has chosen to make salary deferrals to an incentive account.  - (2) Units representing shares of BCO Common Stock were credited to the Reporting Person's account under the Program as a result of a dividend payment, in accordance with the terms of the Program.
 - (3) The number of Units credited to the Reporting Person's account on the Transaction Date is based upon a share price of \$70.25, which is the average trading price of BCO Common Stock for September 2, 2008, calculated in accordance with the terms of the Program.
