Represents Restricted Stock Units ("RSUs") awarded under the Winn-Dixie Stores, Inc. Fiscal 2010 Equity Incentive Plan that were subject to achievement of certain performance criteria determined as to 1/3 of the award each year beginning with the first year after

(1) grant. The aggregate performance RSUs were originally awarded on November 4, 2009. The first year performance criteria were met on November 4, 2010 and the RSUs vested as to 1/3 of the original award. Each RSU represents a right to receive one share of Winn-Dixie Stores, Inc. common stock.

(2) Shares sold to satisfy tax withholding obligations.

The price shown is the weighted average price at which shares were sold in multiple sales transactions made pursuant to a single market

(3) order. The range of prices for the transactions made was \$7.113 to \$7.143. Upon request by SEC staff, the issuer or a security holder of the issuer, the reporting person will provide full information regarding the number of shares sold at each separate price.
