## Explanation of Responses:

- (1) This transaction represents the withholding by Issuer of shares to pay taxes in connection with the vesting of a Restricted Stock Unit ("RSU") award. The timing and amount of the transaction were determined by the terms of the applicable RSU award and were not within the control of the Reporting Person.
- (2) The Form 4 filed on February 2, 2011 erroneously reflected the vesting of 5,516 RSUs on January 31, 2011, but only 3,992 RSUs vested on that date. The combined total of Common Stock and RSUs in Column 5, which were previously reported as separate line items in Table I, accurately reflected, on a combined basis, the directly owned Common Stock and RSUs of the reporting person.
- (3) Not included in this amount are 3,732 and 5,095 Performance-Based Restricted Stock Units, of which from 0% to 100% are eligible to vest on January 1, 2013 and January 1, 2014, respectively, subject to the Issuer's achievement of certain financial goals over a three-year period and certification by the Management Development and Compensation Committee.
