Effective immediately after the spin-off on June 30, 2011, of Marathon Petroleum Corporation ("MPC") by Marathon Oil Corporation ("MRO"), the reporting person ceased to be a director of Marathon Oil Corporation and became a director of Marathon Petroleum Corporation.
