- (1) (TF1) As previously reported, on February 25, 2010, the reporting person received a grant of 362,723 performance restricted units that were subject to the issuer's attainment of a specified one-year performance metric for the year then-ending December 31, 2010. The performance metric was met; therefore, these restricted units vest ratably on each of the first, second and third anniversaries of the date of grant. The first anniversary of this grant occurred on February 25, 2011, resulting in the vesting and settlement of 120,907 shares of common stock. The second anniversary of this grant occurred on February 25, 2012, resulting in the vesting and settlement of 120,908
