- (1) Represents the conversion upon vesting of restricted stock awards into common stock (the "Converted Common Stock #1"). On February 29, 2012, the reporting person was granted 2339 restricted stock awards, of which 1/3 of the shares subject to the restricted stock units vested on February 28, 2013. On February 29, 2012, the reporting person was granted 2339 restricted stock units, of which 1/3 of the shares subject to the restricted stock award vested on February 28, 2013. The common stock into which such vested restricted stock units converted on February 28, 2013 is reported in Table I on this Form 4. The remaining unvested restricted stock units will continue to vest as to 1/3 of the original number of shares subject to the restricted stock awards on each succeeding February 28th until fully vested.
 - (4) 8000 options were granted to the Reporting Person on 2/28/2013. Such options vest in three installments beginning on the first anniversary of the date of grant (2/28/2014).
 - (6) Each restricted stock award represents the contingent right to receive one share of common stock upon vesting of the unit.
 - (7) This restricted stock award vests in three installments beginning on the first anniversary of the date of the grant of restricted stock.
