- (1) Reflects a grant of Restricted Stock Units ("RSUs") that shall vest in substantially equal one-twelfth increments on each of the following dates as long as Director serves continuously on the Board through the applicable vesting date: May 31, 2013, June 30, 2013, July 31, 2013, August 31, 2013, September 30, 2013, October 31, 2013, November 30, 2013, December 31, 2013, January 31, 2014, February 28, 2014, March 31, 2014 and the earlier of (a) April 30, 2014 or (b) the day immediately preceding the date of the 2014 annual meeting of the Company's shareholders. The number of RSUs was determined by dividing \$80,000 by \$46.36, the closing price of the Issuer's Common Stock on the New York Stock Exchange on the day before the grant.
- (2) Represents shares allocable to the outside directors' deferred fee plan account under the Cash America International, Inc. 1994 Long-Term Incentive Plan and the Cash America International, Inc. First Amended and Restated 2004 Long-Term Incentive Plan, as amended, and reflects an adjustment for dividends paid to the Reporting Person pursuant to the dividend reinvestment provisions of such plans. All shares are held by the trustee of the plans in a Rabbi trust.
