In addition, each share of Class B Common Stock will convert automatically into one (1) share of Class A Common Stock upon any transfer, whether or not for value, which occurs after the closing of the IPO, except for certain permitted transfers described in, and transfers to any "permitted transferee" as defined in, the Issuer's restated certificate of incorporation. All shares of Class A and Class B Common Stock will convert automatically into shares of a single class of Common Stock upon the earliest to occur of the following: (a) upon the election by the holders of a majority of the then outstanding shares of Class B Common Stock or (b) October 15, 2023.

(8) On July 7, 2015, the Reporting Person's grantor retained annuity trust returned 34,000 shares of Class B Common Stock to the Reporting Person as an annuity payment. The Reporting Person expects to receive annuity payments from the trust annually.

(9) Excludes 34,000 shares of Class B Common Stock now held directly by the Reporting Person.
