- (1) Grant of restricted stock units to the Reporting Person under the Company's Long Term Incentive Plan. No amount was paid upon grant of the units. The Time-Based Units vest 33-1/3% per year, beginning on November 4, 2016. All Performance-Based Units are based upon the achievement of performance metrics measured over a three year period ending on September 30, 2018 and will vest at the end of such period.
