(1) On 8/10/2017, the reporting person was granted a performance-based restricted stock unit award under the Company's 2015 Stock Option and Incentive Plan, which awards vest only upon the Company's achievement of two weighted performance metrics: revenue (50%) and non-GAAP operating income targets (50%) for fiscal year ending 3/31/18 ("FY18"). On 5/23/18, our board approved that the reporting person earned the above number of shares based on the Company's achievement of i) revenue of \$1,020.67 million and ii) Non-GAAP operating income of \$87.08 million for FY18. Of the shares that were earned, 33% will vest on 9/1/2018 and 67% will vest on 3/1/2020, based on continued service of the reporting person.
