(2) The reported transactions were executed in multiple trades. The purchase price of \$17.5199 reported in Column 4 is the weighted average purchase price for the 20,000 shares acquired by the Reporting Person within a range of \$17.40 to \$17.60 per share. (3) Of the 44,827,130 shares of Class A Common Stock reported herein, (i) 40,280,778 shares of Class A Common Stock are owned by MacAndrews & Forbes Incorporated ("M&F"), of which Ronald O. Perelman is the sole stockholder, or its wholly-owned subsidiaries; and (ii) 4,546,352 shares of Class A Common Stock are owned by Perelman Trust Company, LLC, over which M&F exercises voting control.
