**SUBMISSION OF MATTERS TO A VOTE OF SECURITY HOLDERS**

On May 10, 2013, WWA Group, Inc. (the Company) held a Special Meeting of its shareholders to consider the terms and conditions of a Share Exchange Agreement dated July 10, 2012, in connection with the intention to acquire Summit Digital, Inc. as a wholly owned subsidiary and to consider an amendment to the Company's articles of incorporation that would increase the number of authorized common shares to two hundred and fifty million (250,000,000) par value \$0.001. A third proposal that would authorize the board of directors to adjourn the Special Meeting in the event insufficient votes were cast in respect to Proposals 1 and 2 was approved though no action was necessary since sufficient votes were cast to act on said proposals.

The first proposal to approve the acquisition of Summit Digital, Inc. was approved as follows:
