Item 4. Ownership.
(a) and (b):
As of the close of business on December 31, 2017, each of the Reporting Persons may be deemed to have beneficial ownership of 1,279,753 shares of Common Stock issuable upon exercise of the Intracoastal Warrant, and all such shares of Common Stock in the aggregate represent beneficial ownership of approximately 9.99% of the Common Stock, based on (1) 11,530,591 shares of Common Stock outstanding as of November 1, 2017 as reported by the Issuer, plus (2) 1,279,753 shares of Common Stock issuable upon exercise of the Intracoastal Warrant. The foregoing excludes 720,247 shares of Common Stock issuable upon exercise of the Intracoastal Warrant because the Intracoastal Warrant contains a blocker provision under which the holder thereof does not have the right to exercise the Intracoastal Warrant to the extent that such exercise would result in beneficial ownership by the holder thereof, together with the holder's affiliates, and any other persons acting as a group together with the holder or any of the holder's affiliates, of more than 9.99% of the Common Stock. Without such blocker provision, each of the Reporting Persons may have been deemed to have beneficial ownership of 2,000,000 shares of Common Stock.
