Holders of 8,081,217 shares of the Company's ordinary shares were present in person or by proxy at the annual meeting, representing approximately 52.78% of the total 15,310,314 outstanding ordinary shares and therefore constituting a quorum of more than a third of the shares outstanding and entitled to vote at the annual meeting as of the record date of December 26, 2018.
