As President of SMP Asset Management, LLC, which is General Partner of Santa Monica Partners, L.P., and (1) of Santa Monica Partners Asset Management, LLC, which is a General Partner of Santa Monica Partners II, L.P., Mr. Goldstein beneficially owns indirectly 673,000 shares and 28,709 shares, respectively. Mr. Goldstein contributed 3,000 shares to the Barbara J. & Lawrence J. Goldstein Do Good Foundation, Inc. Mr. Goldstein has beneficial ownership but not record ownership of these shares.
