- (1) The transactions reported on this Form 4 were effected pursuant to a Rule 10b5-1 plan adopted by the reporting person on May 5, 2010. This non-qualified employee stock option grant and its companion incentive employee stock option grant, together totaling 70,000 options, were granted to the reporting person on 10/7/2009. On 10/7/2010, 25% of the shares from the grants vested and became exercisable. The remaining 75% of the shares will begin vesting in 36 equal monthly installments on 11/7/2010.
