**Item 8.01 Other Events.**

On March 31, 2006, Western Alliance Bancorporation (the "Company") completed its acquisition of Intermountain First Bancorp ("Intermountain") and its wholly owned subsidiary, Nevada First Bank, pursuant to an Agreement and Plan of Merger, dated December 30, 2005, between the Company and Intermountain (the "Agreement").
