On November 22, 2006, Selim A. Bassoul, Chairman, Chief Executive Officer and President of The Middleby Corporation (the "Company") and Timothy J. FitzGerald, the Company's Vice President and Chief Financial Officer, each amended stock trading plans pursuant to Rule 10b5-1 of the Securities Exchange

Act of 1934, as amended. The plans were amended to defer the effective date of the plans from November 22, 2006 to March 15, 2007. Additionally, the plans provide for the sale of shares of stock at predetermined minimum price thresholds. These predetermined price thresholds were increased from a range of \$80 to \$95 to a range of \$110 to \$125. Mr. Bassoul's plan provides for the sale of up to 252,000 shares of Company common stock over a period of two years commencing on March 15, 2007. Mr.

FitzGerald's plan provides for the sale of up to 37,808 shares of Company common stock over a period of two years commencing on March 15, 2007.
