(1) Twenty-five percent (25%) of the total options granted vest and become exercisable one year after the date of grant and thereafter with respect to 6.25% of the shares each quarter until fully vested.

On 08/01/2006, Reporting Person was awarded restricted stock units (RSUs). Each RSU represents a contingent right to receive one (1) share of VeriSign common stock once vested. Twenty-five percent (25%) of the grant vests over four years on the anniversary of the date of grant, subject to necessary withholding for applicable taxes.

(3) Exercisable immediately as to 3,125 shares with the remainder exercisable at the rate of 6.25% of the total grant quarterly thereafter.

(4) Are exercisable as to 6.25% of the shares each quarter after the date of grant.
