**ANNOUNCEMENT**

**Medellín, Colombia, September 16, 2007**

In connection with the investigation of an alleged *prevaricato* (unlawful approval of a transaction) by the Board of Directors of the Central Bank of Colombia and the Board of Directors and the President of Banco Industrial Colombiano (BIC) during the acquisition of Banco de Colombia and its subsequent merger, Bancolombia S.A. (Bancolombia) reaffirms the view it has maintained for almost 10 years.

The Attorney General's Office No. 218 of the First Unit of Crimes against the Public Administration and Justice of Bogotá (*Fiscal Delegada 218 de la Unidad Primera de Delitos contra la Administración Pública y de Justicia de Bogotá*), revoked its previous decision which had precluded the proceeding against the President of BIC, Mr. Jorge Londoño Saldarriaga, on July 31, 2006, in an investigation initiated against the officers of the former Superintendency of Banking and former Superintendency of Securities relating to the authorizations granted for the transaction.

Bancolombia reaffirms its view that the acquisition process of Banco de Colombia by BIC and the subsequent merger of these two entities were conducted in accordance with international customary standards and practices for this type of transaction, and in accordance with Colombian law. This acquisition process was validated at the time by the respective Colombian authorities.
