**SCHEDULE 13G/A**

This Amendment No. 2 to Schedule 13G (the "Schedule 13G") is being filed on behalf of Fir Tree SPAC Holdings 1, LLC, a Delaware limited liability company ("SPAC Holdings 1"), Fir Tree SPAC Holdings 2, LLC, a Delaware limited liability company ("SPAC Holdings 2"), Fir Tree Value Master Fund, L.P., a Cayman Islands exempted limited partnership ("Fir Tree Value") and Fir Tree, Inc., a New York corporation ("Fir Tree"), relating to common stock, par value \$0.0001 (the "Common Stock") of Hicks Acquisition Company I, Inc., a Delaware corporation (the "Issuer"), owned by SPAC Holdings 1, SPAC Holdings 2 and Fir Tree Value. Fir Tree SPAC Master Fund, LP, a Cayman Islands exempted limited partnership ("Fir Tree SPAC Master"), is the sole member of SPAC Holdings 1 and SPAC Holdings 2, and Fir Tree is the investment manager of SPAC Holdings 1, SPAC Holdings 2 and Fir Tree Value.

In addition to updating the holdings of the Reporting Persons, this Amendment is being filed to report that Sapling, LLC, a Delaware limited liability company, and Fir Tree Capital Opportunity Master Fund, L.P., a Cayman Islands exempted limited partnership, transferred ownership of their shares of Common Stock to SPAC Holdings 1, SPAC Holdings 2 and Fir Tree Value and consequently ceased to be Reporting Persons.

Fir Tree, Inc. is the investment manager for each of SPAC Holdings 1, SPAC Holdings 2 and Fir Tree Value, and has been granted investment discretion over portfolio investments, including the Common Stock (as defined below), held by each of them.

**Item 4 Ownership.**

- (a) SPAC Holdings 1, SPAC Holdings 2 and Fir Tree Value are the beneficial owners of 3,893,253 shares of Common Stock, 1,641,138 shares of Common Stock and 625,609 shares of Common Stock, respectively. Fir Tree may be deemed to beneficially own the shares of Common Stock held by SPAC Holdings 1, SPAC Holdings 2 and Fir Tree Value as a result of being the investment manager of SPAC Holdings 1, SPAC Holdings 2 and Fir Tree Value.
- (b) SPAC Holdings 1, SPAC Holdings 2 and Fir Tree Value are the beneficial owners of 5.6%, 2.4% and 0.9%, respectively, of the outstanding shares of Common Stock. Collectively, the Reporting Persons beneficially own 6,160,000 shares of Common Stock which represent 8.9% of the shares of Common Stock outstanding. These percentages are determined by dividing the number of shares of Common Stock beneficially held by 69,000,000, the number of shares of Common Stock issued and outstanding as of November 14, 2008, as reported in the Issuer's 10-Q filed with the Securities and Exchange Commission on November 14, 2008.

- (c) SPAC Holdings 1 may direct the vote and disposition of 3,893,253 shares of Common Stock. SPAC Holdings 2 may direct the vote and disposition of 1,641,138 shares of Common Stock. Fir Tree Value may direct the vote and disposition of 625,609 shares of Common Stock. Fir Tree has been granted investment discretion over the Common Stock held by SPAC Holdings 1, SPAC Holdings 2 and Fir Tree Value.

Fir Tree SPAC Master, as the sole member of SPAC Holdings 1 and SPAC Holdings 2, has the right to receive dividends from and the proceeds from the sale of the shares of Common Stock.
