- (1) Acquisition of common stock resulting from the vesting of one-third of the restricted stock units granted to Ms. Fisch on February 15, 2012.
- (2) On August 6, 2013, AmTrust Financial Services, Inc. declared a 10% stock dividend payable on September 4, 2013 to all holders of record of common stock as of August 20, 2013. As a result, the reporting person received 385 shares of AmTrust Financial Services, Inc. common stock on September 4, 2013.
- (3) Each restricted stock unit represents a contingent right to receive one share of AmTrust Financial Services, Inc.'s common stock.
- (4) On February 15, 2012, Ms. Fisch received restricted stock units subject to a three-year vesting schedule, vesting one third on each of the first, second and third anniversaries of the grant date. As restricted stock units vest, the vested units are automatically converted to vested common stock on a one-for-one basis on the vesting date.
- (5) Pursuant to anti-dilution provisions in AmTrust Financial Services, Inc.'s 2010 Omnibus Incentive Plan, 2,200 restricted stock units granted to Ms. Fisch on February 15, 2012 and held on September 4, 2013 became 2,420 restricted stock units.
