In addition, each share of Class B Common Stock will convert automatically into one share of Class A Common Stock upon any transfer, whether or not for value, except for certain permitted transfers described in the Issuer's Amended and Restated Certificate of Incorporation.

(2) Represents shares distributed directly or indirectly from Settlement T-2390-A. No consideration was paid in connection with such distribution. The distribution of Class B Common Stock to 2010 N3 Purpose Trust constitutes a "permitted transfer" as defined under the Issuer's Amended and Restated Certificate of Incorporation. JP Morgan Trust Company (Bahamas) Limited, solely in its capacity as trustee of the Reporting Person, previously executed a joinder to, and is therefore subject to the provisions of, the Amended and Restated Foreign Global Hyatt Agreement. Accordingly, immediately following the distribution, the shares will remain shares of the Class B Common Stock.
