- (ii) options to purchase 58,923 shares of common stock held by Mr. Sampson and exercisable within 60 days of December 31, 2018;
- (a) (iii) 38,895 shares of the Issuer held by Mr. Sampson through the Communications Systems, Inc. Employee Stock Ownership Plan (“CSI ESOP”);
- (iv) 26,114 shares owned by Mr. Sampson’s spouse; and
- (vi) 7,000 shares held by the Sampson Family 2008 Irrevocable Trust, 20,000 shares owned by the Sampson Family Foundation and 423,000 shares held by the Curtis A. Sampson 2012 Family Irrevocable Trust. Mr. Sampson serves as a trustee of the Foundation and the two trusts, which were established for the benefit of Mr. Sampson’s children and grandchildren.
