National Bankshares, Inc.'s Board of Directors on February 13, 2019 approved an amendment to its stock repurchase program authorizing management to repurchase up to an additional 750,000 shares of National Bankshares, Inc. common stock. This authorization expands the 250,000 share repurchase program that was approved on November 14, 2018, bringing the total authorized repurchase amount to 1,000,000 shares through May 31, 2019. The Company's management has not yet determined how many shares, if any, might be purchased under the continued stock repurchase plan.
