- (1) Grant to reporting person of restricted common shares pursuant to the Amended and Restated Nordson Corporation 2004 Long-Term Performance Plan. Restriction on transfer of shares lapses after two years following date of grant.
- (2) On April 12, 2011, the common stock of Nordson Corporation split 2-for-1, resulting in the reporting person's ownership of 264 additional shares of common stock.
- (3) Restricted share units acquired through deferral of grant of restricted shares under Directors' Deferred Compensation Plan.
- (4) Restricted share units vest two (2) years after the grant date and convert to an equal number of share equivalent units on the vesting date.
- (5) On April 12, 2011, the common stock of Nordson Corporation split 2-for-1, resulting in the reporting person's ownership of 2,380 additional Restricted Share Units.
- (6) Share equivalent units accrued through Nordson's Directors' Deferred Compensation Plan. At time of distribution, share equivalent units convert to common shares on a one-for-one basis. Distribution is not permissible until participant ceases to be a Director.

(7) Share Equivalent Units accrued through dividend payment.

(8) On April 12, 2011, the common stock of Nordson Corporation split 2-for-1, resulting in the reporting person's ownership of 2,554 additional Share Equivalent Units.
