ESP is the record holder of the Common Units of the Issuer ("Units") reported in this line on this Form 4 and has a direct pecuniary interest in the Units. ESSC, ESLLC, and ESCLP beneficially own the Units for the purposes of Section 13(d) of the Exchange Act and have an indirect pecuniary interest in the Units.
 - (1) On July 20, 2016, ESP sold 7,069 Units on the New York Stock Exchange in open market sales, at prices ranging from \$12.00 to \$12.05 per Unit, with a weighted-average per-Unit price of \$12.0071.
 - (2) On July 21, 2016, ESP sold 34,030 Units on the New York Stock Exchange in open market sales, at prices ranging from \$12.0000 to \$12.2050 per Unit, with a weighted-average per-Unit price of \$12.0528.
